About Henry Mayo Newhall Hospital

Henry Mayo Newhall Hospital is a 357-bed, nonprofit, acute care hospital, which has served the Santa Clarita Valley since 1975. Henry Mayo is an Advanced Primary Stroke Center and a STEMI Receiving Center. The hospital features state-of-the-art inpatient facilities, a neonatal intensive care unit, catheterization lab, breast center and an outpatient surgery center. Additional services include cardiovascular, trauma, emergency, intensive care, maternity, surgery, wound care, spine and joint, behavioral health, and acute rehab, as well as oncology, imaging, lab, digestive, respiratory services and physical and occupational therapies.

Henry Mayo Hospital is proud to have won a National Award of Merit, in the Healthcare Facilities category, from the Design-Built Institute of America (DBIA), for the design and construction of the hospital's patient tower. The tower includes 90 private rooms and a Center for Women and Newborns.

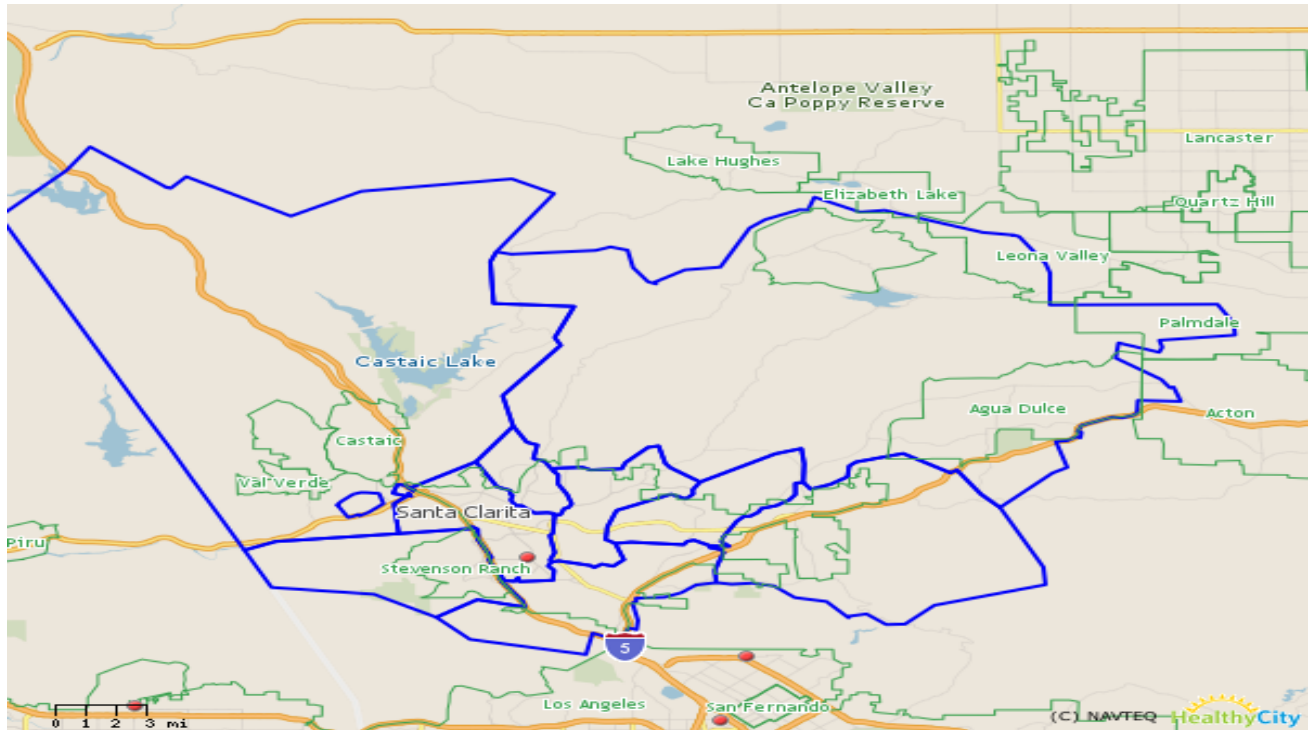
Service Area

Community Snapshot

The population of the Henry Mayo service area is 275,772. Children and youth, ages 0-17, make up 25.3% of the population, 63.5% are 18-64 years of age, and 11.2% are seniors, 65 years and older. In the service area, 46.4% of the population are White residents, 33.3% are Hispanic or Latino residents, 10.9% of the residents are Asian, 4.3% of residents are Black or African American, and the remaining 5.1% of the population are American Indian or Alaskan Native residents, Native Hawaiian or Pacific Islander residents, some other race or multiracial residents. For 63.3% of the area population, English is the only language spoken at home. Spanish is spoken at home among 19.1% of the population, and 6.1% of the population speaks an Asian language in the home. 9.7% of the population are at or below 100% of the federal poverty level (FPL) and 17.4% of the population in the service area are considered low-income, living at or below 200% of FPL. Among area adults, ages 25 and older, 10.1% lack a high school diploma and 46.7% are college graduates.

Community Health Needs Assessment

Henry Mayo completed a Community Health Needs Assessment (CHNA) in FY22, as required by state and federal law. The CHNA is a primary tool used by Henry Mayo to determine its community benefit plan, which outlines how it will give back to the community in the form of health care and other community services to address unmet community health needs. The assessment incorporated components of primary data collection and secondary data analysis that focused on the health and social needs of the service area.

The CHNA examined up-to-date data sources for the service area to compile community demographics, social determinants of health, health care access, birth indicators, leading causes of death, COVID-19, acute and chronic disease, health behaviors, mental health, substance use, and preventive practices.

Henry Mayo conducted targeted interviews to gather information and opinions from persons who represent the broad interests of the community served by the hospital. There were twenty-one (21) interviews completed in March 2022. Leaders and/or representatives of medically underserved, low-income, and minority populations, local health or other departments or agencies that have current data or other information relevant to the health needs of the community were represented in the sample. Input was obtained from the Los Angeles County Department of Public Health.

Priority Health Needs

The list of significant health needs informed primary data collection. The secondary data collection process was designed to validate primary data findings, identify additional community issues, and to solicit information on disparities among subpopulations, ascertain community assets to address needs and discover gaps in resources. Community stakeholders prioritized the significant health needs using the following criteria:

- The perceived severity of a health issue or health factor/driver as it affects the health and lives of those in the community.
- Improving or worsening of an issue in the community.
- Availability of resources to address the need.

The stakeholders were also asked to prioritize the health needs according to the level of importance the hospital should place on addressing the issue. Access to care, mental health, substance use, housing and homelessness, and chronic diseases were ranked as the top five priority needs in the service area. The calculations of the community input resulted in the following priority ordering of the significant health needs:

1. Access to health care
2. Mental health

3. Substance use
4. Housing and homelessness
5. Chronic diseases
6. Preventive practices (screenings and vaccines)
7. COVID-19
8. Overweight and obesity (healthy eating and physical activity)

Addressing Priority Health Needs

In FY22, Henry Mayo engaged in activities and programs that addressed the priority health needs identified in the FY20-FY22 Implementation Strategy. Henry Mayo has committed to community benefit efforts that addressed access to health care (including specialty care), chronic diseases (cancer, heart disease, and diabetes), mental health, substance use and misuse, and preventive practices. Selected activities and programs that highlight Henry Mayo's commitment to the community are detailed below.

Access to Care and Preventive Practices (Including Specialty Care)

Access to care is a key determinant of health that provides preventive measures and disease management, which reduces the likelihood of hospitalizations and emergency room admissions. Routine health care includes screenings, check-ups, and counseling to prevent illness, disease, or other health problems. Individuals who receive services in a timely manner have a greater opportunity to prevent or detect disease during earlier, treatable stages.

Response to Need

Consistent with Henry Mayo's financial assistance policy, Henry Mayo provided financial assistance through free and discounted care for health care services, facilitated access to health care services, and offered information and enrollment assistance in low-cost insurance programs. Transportation assistance was provided to community residents who lacked the resources to obtain transportation to or from needed health care services.

Henry Mayo sponsored two free community health fairs.

Henry Mayo served as a COVID-19 vaccine distribution center and provided free vaccines through the LA County Department of Public Health. In all the hospital provided the community with over 50,000 vaccine doses.

Henry Mayo provided flu shots to approximately 220 community residents.

As part of our Fall Prevention Program, Henry Mayo introduced AvaSure's TeleSitter Technology, a system that is designed to connect caregivers more closely with patients and families, while improving the quality of care. The device provides real-time, continuous video surveillance of patients, from a remote station with two-way audio, which allows immediate intervention to prevent harm to patients.

Athletic trainers from Henry Mayo assisted Hart School District student athletes. Our highly skilled trainers provided sports physicals, education and training to prevent sports injuries to our athletes in Santa Clarita.

Henry Mayo hosted twelve American Red Cross blood drives. We collected 663 units of life saving blood, which will directly affect the lives of up to 1,989 people as they battle cancer, receive a transfusion for a blood disorder or undergo surgery. In FY22 there were 119 first time donors and 132 units of Power Red (two units of red blood cells) donations. We also published a podcast titled *Donating Blood - Why It's So Important*.

The Henry Mayo online health information library was made available to patients, families and the public. Preventive health care messages and wellness resources were made available.

Henry Mayo physical therapists provided lectures and training to senior centers, schools and local organizations.

To confirm our commitment to provide a larger network of doctors, we recruited an additional psychiatrist for our Behavioral Health Unit.

Chronic Diseases (Cancer, Heart Disease, Diabetes)

Chronic diseases are long-term medical conditions that tend to progressively worsen. Chronic diseases, such as cancer, heart disease, and diabetes are major causes of disability and death. Chronic diseases are also the major causes of premature adult deaths. In Henry Mayo's service area (SPA2), cancer is the leading cause of death and heart disease is the second leading cause of death.

Response to Need

Henry Mayo partnered with Keck Medicine of USC to bring advanced health care services directly to the Santa Clarita Valley and surrounding areas. The collaboration launched with the opening of a USC Norris Comprehensive Cancer Center Radiation Oncology clinic on the Henry Mayo campus.

Henry Mayo's Cancer services included:

- Cancer Prevention – Henry Mayo offered screening services, nutrition and health education classes and community events to increase awareness in the Santa Clarita Valley.
 - Sheila R. Veloz Breast Center
 - Lung Cancer Screening Program
 - Tobacco Cessation
 - Community Education Classes
 - Let's Get Back to Screening

- Henry Mayo participated in community cancer events:
 - The American Cancer Society Relay for Life
 - During Breast Cancer Awareness Month, Henry Mayo provided free educational

information.

- Over 500 persons were reached at the Breast Cancer at Relay for Life 2022.
- Henry Mayo and Keck Medicine provided a Let's Get Back to Cancer Screening Symposium. Over 100 community members attended the event.
- Celebrated and supported breast Cancer Awareness Month with multiple events in the community.
- Supported Circle of Hope, an organization that provides financial assistance for patients in need.

In celebration of National Nutrition Month, Henry Mayo offered activities that focused on the importance of nutrition and healthy eating. This year's theme of World of Flavors included a discussion on healthy food choices. Events included outreach at the local Farmers Market, where visitors could test their nutrition knowledge and learn easy steps to help improve their health and the health of their families.

In partnership with the City of Santa Clarita Library, Henry Mayo offered family nutrition classes in English and Spanish.

Henry Mayo offered PreventT2, a lifestyle change program recognized by the CDC that focused on those who are at risk of developing diabetes. The program provided information on how to reduce blood sugar, lose weight and reverse pre-diabetes. Guided by trained lifestyle coaches and athletic trainers, participants learned skills to lose weight, be more physically active and manage stress. The 12-month program met three times a month, for six months, and two times a month, for the remaining six months.

A Diabetes Self-Management class was offered as a two-part class for people who have Type 1 or Type 2 diabetes. Topics included Managing your Diabetes, Monitoring your Blood Glucose, Nutrition, and Continuing Your Journey with Diabetes. There were 26 classes held. The Diabetes Prevention Program engaged 332 participants while 125 participants attended the Diabetes Self-Management Education sessions. A Spanish speaking educator was hired to reach the Hispanic or Latino community.

It's Your Health radio is a free, bimonthly health podcast produced by Henry Mayo. Physician and health care experts spoke on a variety of topics, including prostate and colon health, cancer, healthy eating, diabetes management, pain management, wound care, urological disorders, postpartum depression and heart health. The podcast reached over 3,500 listeners. In addition, Henry Mayo distributed the *It's Your Health* magazine twice during the year to residents in the Santa Clarita Valley. The magazine included information for living a healthy lifestyle and health resources.

Over 535 community residents learned life-saving CPR through the hospital's Certified CPR Community Class in FY22. Additionally, 292 support groups served 1,814 community members. The support groups included: Cancer survivorship, Stroke, Arthritis, Chronic pain, Type one-derful, SCAPPI amputee, and Aphasia.

Mental Health and Substance Use and Misuse

Positive mental health is associated with improved health outcomes. Indicators and contributors to poor mental health may include chronic stress due to financial worry, work pressures, family demands, poverty and low-levels of education. The need to expand access to mental health services was noted as a high priority among community members. Community members also noted an increase in vaping among teens and an increase in marijuana use.

Response to Need

Henry Mayo's Behavioral Health Unit is an LPS-designated acute psychiatric care facility, for adult male or female patients in psychological crisis. The Unit treated persons with a wide range of acute psychiatric illnesses, including major depression, bipolar disorder, schizoaffective disorder and schizophrenia. Patient services included assessment of emotional and psychological issues, initial health screening, case management, medication management, treatment planning, community integration planning and referrals. Henry Mayo also collaborated with ROWI, an on-site mental health treatment facility for teens. Increasingly, operating this Unit has become financially challenging due to the significant shortfall in funding for these services.

Henry Mayo partnered with the NAMI National Alliance for Mental Illness to provide mental health awareness classes to the community. These included: Maintaining Your Wellbeing, S.P.I.R.T (Suicide Prevention, Intervention and Response Training) and Digital Detox.

Henry Mayo hosted Practice Mindful and Strong and Coming to Know Yourself, relaxation classes that are focused on reducing stress, anxiety and depression. The class helped to reduce sleep disturbances and chronic pain, and improved self-esteem and develop positive relationships. 155 community members participated in these classes in FY22.

We also hosted Mindful and Strong and Coming to Know Yourself, relaxation classes focused on reducing stress, anxiety and depression. The classes helped reduce sleep disturbances, lessen chronic pain, improve self-esteem and support positive relationships.

Along with the mental health classes, we provided multiple support groups for community members who are dealing with mental health issues. Some of the support groups we provided are:

- ASCA (Adult Survivors of Child Abuse)
- DBSA (Depression Bipolar Support Alliance)
- Alzheimer's Caregiver

- Women for Sobriety

In FY22, approximately 912 community members participated in our classes and support groups.

Additionally, Henry Mayo offered 718 free community classes and events in FY22, which reached 7,424 community members. Topics included Mindful and Strong, Coming to Know Yourself, Nutrition to Boost Your Brain, Maintaining Your Wellbeing, and Recovery. Additionally, 148 support groups served 912 community members. Support groups focused on mental health and substance abuse included: Grief, Alzheimer’s caregiver, Chronic Pain, Women for Sobriety, and OCD.

Henry Mayo’s drug takeback program offered a convenient and safe environment for the community to deposit unused prescription medicines. Nearly 4,000 pounds of medications were turned into the hospital receptacle in FY22.

Other Community Benefit Services

Henry Mayo provided a number of community benefit services in addition to those programs focused on addressing priority health needs.

Health Professions Education

Definition: education programs for physicians, nurses, nursing students, and other health professionals.

Henry Mayo served as a health education-training site for precepting students in the health professions. The hospital worked with nursing, respiratory therapy, pharmacy and laboratory students.

Subsidized Health Services

Definition: clinical programs that are provided, despite a financial loss. Negative margins remain after accounting for charity care, bad debt and shortfalls from Medi-Cal. The services meet a community need and, if not offered, would be unavailable in the area or become the responsibility of the government or another non-profit organization.

Behavioral Health Unit – an LPS-designated acute psychiatric care facility (Sections 5150, 5151 and 5152 of the California Welfare and Institutions Code) for adult male or female patients in psychological crisis. The Unit treated persons with a wide range of acute psychiatric illnesses, including major depression, bipolar disorder, schizoaffective disorder and schizophrenia. Patient services included assessment of emotional and psychological issues, initial health screening, case

management, medication management, treatment planning, community integration planning and referrals.

Cash and In-Kind Donations

Definition: funds and in-kind services donated to community groups and nonprofit organizations.

The hospital provided in-kind donations of meeting space to nonprofit organizations and community groups. Additionally, monetary contributions were made to nonprofit organizations that supported community benefit efforts and addressed significant health needs in the community. Community Benefit Operations

Community Building Activities

Definition: activities that support community assets by offering the expertise and resources of the hospital organization. These activities may address the root causes of health problems or the determinants of health, such as education, homelessness, poverty and the environment.

Community Benefit Plan FY23

Henry Mayo continues to implement activities and programs to address the priority needs in our service area.

Significant Needs the Hospital Intends to Address

Henry Mayo intends to take actions to address the following health needs, which were identified in the FY19 CHNA and detailed in the FY23-FY25 Implementation Strategy:

- Access to care (including specialty care)
- Chronic disease (including overweight and obesity)
- Mental health and substance use
- Preventive care

Health Need: Access to Health Care and Preventive Practices (Including Access to Specialty Care)

Strategy

Increase access to health care and preventive care. Reduce barriers to health care, including specialty care, for the medically underserved, and increase compliance with preventive care recommendations.

Actions

1. Provide financial assistance through free and discounted care for health care services, consistent with the hospital's financial assistance policy.
2. Provide transportation support to increase access to health care services.
3. A registered nurse will answer health questions for residents of Bella Vida senior center. A pharmacist will provide medication review for senior center residents.
4. Offer free flu shots in the community.
5. In partnership with Keck Medicine of USC, provide access to cancer care and other specialty services.
6. Provide community health education and awareness events to encourage healthy behaviors and prevent accidents and disease.
7. Provide donations and in-kind support to nonprofit community organizations that address access to health and preventive services.

Health Need: Chronic Diseases (Including Overweight and Obesity)

Strategy

Increase the identification and treatment of chronic diseases, increase public awareness of the impact of chronic diseases on health, improve healthy eating behaviors and increase physical activity.

Actions

1. Provide community health sessions focused on chronic disease prevention, management, and treatment, nutrition and healthy eating. Participate in community health awareness and outreach events. Provide free educational information at health fairs.
2. Provide diabetes self-management classes for persons with Type 1 or Type 2 diabetes. Offer PreventT2, a lifestyle change program that focuses on those who are at risk of developing diabetes. The 12- month program has received full recognition from the CDC.
3. Provide free bimonthly health podcasts and twice-yearly print magazine that focus on disease management and healthy lifestyle topics.
4. Provide support groups for persons with chronic diseases and their families or caregivers.
5. Provide cancer-screening services, smoking cessation, nutrition and health education classes and community events to increase cancer prevention awareness in the Santa Clarita Valley.
6. Host community health education and wellness fairs, including, blood pressure, carotid artery, and derma scan screenings along with smoking cessation and CPR classes.
7. Provide donations and in-kind support to nonprofit community organizations dedicated to addressing chronic diseases, healthy eating and physical activity.

Health Need: Mental Health and Substance Use and Misuse

Strategy

Increase access to mental health and substance use services in the community and improve screening, prevention, and treatment of mental health and substance use conditions.

Actions

1. Henry Mayo's Behavioral Health Unit is an LPS-designated acute psychiatric care facility, for adult male or female patients in psychological crisis. The Unit will treat persons with a wide range of acute psychiatric illnesses, including major depression, bipolar disorder, schizoaffective disorder and schizophrenia. Henry Mayo will also collaborate with ROWI, an on-site mental health treatment facility for teens.
2. Provide relaxation classes that focus on reducing stress, anxiety and depression.
3. Offer support groups for community members who are dealing with substance use and mental health issues.
4. Provide education classes to increase knowledge of mental health and substance use issues and to increase awareness of prevention and treatment services available in the community.
5. Provide a safe environment for community members to deposit unused prescription medicines, which can be a source of substance abuse.
6. Provide donations and in-kind support to nonprofit community organizations that address

mental health and substance use services.

Evaluation of Impact

Henry Mayo will monitor and evaluate the programs and activities outlined above. The reporting process includes collection and documentation of tracking measures, such as the number of people reached or served and collaborative efforts to address health needs. Henry Mayo's actions to address these significant health needs will be reported in the next scheduled CHNA.

Needs the Hospital Will Not Address

Taking existing hospital and community resources into consideration, Henry Mayo will not directly address the remaining health need identified in the CHNA, which was housing and homelessness. Additionally, Henry Mayo does not intend to specifically emphasize COVID-19 interventions but will continue to deliver acute medical care and be a community resource for COVID-19. Henry Mayo will concentrate on those health needs that can most effectively be addressed, given the organization's capabilities and resources. The hospital has insufficient resources to effectively address all the identified needs and, in some cases, others currently address the needs in the community. Henry Mayo Newhall Hospital will continue to look for opportunities to address community needs and provide assistance where we can make a meaningful contribution.
